Monday, the **Twenty-Fourth of October, Two Thousand and Twenty-Two, (24/10/2022)**,
located in Samarinda City, Indonesia, the undersigned:

- I. **SUYANTO, H. HUDALI MUKTI, RUSLI, AKHMAD SOPIAN, ABDURROHMAN, ILHAM RAHMATULLAH** are the Deans of the Faculties at Widya Gama Mahakam Samarinda University, located on Jalan K.H. Wahid Hasyim 1, No. 28, Samarinda, East Kalimantan Province, hereinafter referred to this Agreement as the **FIRST PARTY**.
- II. **TOKURO MATSUO** is the CEO of the International Institute of Applied Informatics, located on 302 NK Minami Shinagawa, 3-6-51, Minami Shinagawa, Shinagawa, Tokyo, 140-0004 Japan, hereinafter referred to this Agreement as the **SECOND PARTY**.
- III. **FORD LUMBAN GAOL** is the IEEE Computer Society Indonesia Section Chair, located on Jalan Kebon Jeruk, Number 27 Jakarta, hereinafter referred to this Agreement as **THIRD PARTY**.

The **FIRST PARTY, SECOND PARTY, and THIRD PARTY** hereinafter separately referred to as **PARTIES** and collectively referred to as **PARTIES** in carrying out their respective positions as referred to above, shall first explain as follows:

1. Based on the considerations above and with due observance of the Laws and Regulations of the Republic of Indonesia Number 12 of 2012 concerning Higher Education and Regulation of the Minister of Research, Technology and Higher Education of the Republic of Indonesia Number 4 of 2017 concerning Guidelines for Cooperation in the Ministry of Research, Technology, and Higher Education;
2. Whereas **FIRST PARTY** and **SECOND PARTY** have agreed to cooperate as stated in the Memorandum of Understanding (MOU) between the International Institute of Applied Informatics and Widya Gama Mahakam University Samarinda on March 4, 2019 signed in Samarinda City;
3. Whereas the **FIRST PARTY** is the Deans of Faculties at Widya Gama Mahakam Samarinda University who is responsible to Rector of Widya Gama Mahakam Samarinda University

based on Government Regulation of the Republic of Indonesia Number 66 of 2010 concerning Amendments to Government Regulation of the Republic of Indonesia Number 17 of 2010 concerning Management and Implementation of Education;

4. Whereas the SECOND PARTY is the CEO of the International Institute of Applied Informatics, domiciled at 302 NK Minami Shinagawa, 3-6-51, Minami Shinagawa, Shinagawa, Tokyo, 140-0004 Japan,
5. Whereas the THIRD PARTY is the Chairperson of the IEEE Computer Society Indonesia Section, which is domiciled at Jalan Kebon Jeruk Number 27, Jakarta Indonesia.
6. That the PARTIES based on good faith, the spirit of partnership and togetherness to realize a mutually synergistic cooperation have agreed to hold a Partnership Cooperation.

Based on the foregoing, the PARTIES agree to bind themselves in an Agreement on Assistances in International Accreditation of Higher Education (AHE) - AHE.OR.JP. and Enhancement International Journals for Lecturers at Widya Gama Mahakam Samarinda University and set out the main points of cooperation in this Agreement with the terms and conditions as follows:

Article 1

The purposes and objectives of this Agreement are:

1. Realizing the collaboration between Widya Gama Mahakam Samarinda University with the International Institute of Applied Informatics and the IEEE Computer Society Indonesia Section in terms of Assistances in International Accreditation of Higher Education (AHE) - AHE.OR.JP. and Enhancement International Journals for Lecturers at Widya Gama Mahakam Samarinda University.
2. Realizing the role of academics in of Assistances in International Accreditation of Higher Education (AHE) - AHE.OR.JP. and Enhancement International Journals for Lecturers Widya Gama Mahakam Samarinda University and as one of the realizations of the tri dharma of higher education.

Article 2

1. The object of this Agreement is the Assistances in International Accreditation of Higher Education (AHE) - AHE.OR.JP. and Enhancement International Journals for Lecturers at Widya Gama Mahakam Samarinda University.
2. The scope of this cooperation includes:
 - a. Provision of seminars and trainings related to International Accreditation of Higher Education (AHE) – ahe.or.jp” Enhancement International Journals for Lecturers.
 - b. Assistances in the process of collecting and completing the International Accreditation of Higher Education (AHE) – ahe.or.jp form.
 - c. Assistances in the process of enhancement the International Journals of Lecturers.

Article 3

In implementing this Agreement, the PARTIES have the following rights and obligations:

FIRST PARTY

1. The right of the FIRST PARTY is to obtain assistances from the SECOND PARTY and the THIRD PARTY in International Accreditation of Higher Education (AHE) - AHE.OR.JP. and Enhancement International Journals for Lecturers at Widya Gama Mahakam Samarinda University.
2. The obligation of the FIRST PARTY is to provide the availability of funds, human resources and also tools related to the Assistances of International Accreditation of Higher Education (AHE) - AHE.OR.JP. and Enhancement International Journals for Lecturers at Widya Gama Mahakam Samarinda University.

SECOND PARTY

1. The rights of the SECOND PARTY are support in terms of financing and human resources as well as those related to the activities of Assistances International Accreditation of Higher Education (AHE) - AHE.OR.JP. and Process of Enhancement International Journals for Lecturers at Widya Gama Mahakam Samarinda University.
2. The obligation of the SECOND PARTY is to provide the Assistances of International Accreditation of Higher Education (AHE) - AHE.OR.JP. and Enhancement International Journals for Lecturers at Widya Gama Mahakam Samarinda University are included in accordance with article 3 paragraph 1.

THIRD PARTY

1. The rights of the THIRD PARTY are support in terms of financing and human resources as well as those related to the activities of Assistances International Accreditation of Higher Education (AHE) - AHE.OR.JP. and Process of Enhancement International Journals for Lecturers at Widya Gama Mahakam Samarinda University.
2. The obligation of the THIRD PARTY is to provide the Assistances of International Accreditation of Higher Education (AHE) - AHE.OR.JP. and Enhancement International Journals for Lecturers at Widya Gama Mahakam Samarinda University are included in accordance with article 3 paragraph 1.

Article 4

The costs incurred as a result of the implementation of this Agreement shall be borne by the budget of the PARTIES in accordance with their duties, responsibilities and authorities, as well as other legal and non-binding sources in accordance with the prevailing laws and regulations.

Article 5

This Cooperation Agreement is valid for a period of 5 (five) years from the date of the signing of this Agreement.

Article 6

1. This Agreement may be extended by the PARTIES by first notifying in writing no later than 30 (thirty) calendar days prior to the expiration of this Agreement and obtaining approval from one of the PARTIES.
2. This Agreement may be terminated prior to the term of this Agreement provided that the PARTIES who wish to terminate this Agreement must notify in writing no later than 60 (sixty) calendar days prior to the desired termination date.
3. This Agreement may terminate automatically if there are provisions of laws and regulations and or government policies that do not allow the implementation of this Agreement, regardless of the terms of time.

Article 7

1. The PARTIES agree to monitor and evaluate the implementation of this Agreement periodically every 1 (one) year.
2. The results of monitoring and evaluation as referred to in paragraph (1) are inputs in order to achieve optimal performance results for the PARTIES.
3. Monitoring and evaluation of the implementation of this Agreement can be carried out jointly by the PARTIES or individually according to their needs and mutual agreement.
4. The results of the monitoring and evaluation are submitted to the person in charge of the PARTIES to be used as the basis for service improvement and a review of the Agreement.

Article 8

1. Condition of force majeure is meant by force majeure is an event that occurs beyond the capabilities of the PARTIES which results in the non-fulfillment of the rights and obligations of the PARTIES.
2. In a force majeure as referred to in paragraph (1), the PARTIES affected by a force majeure must notify one of the parties in writing within 7 (seven) calendar days from the start of the incident accompanied by an official statement from the competent authorities.
3. The PARTIES are freed to carry out the rights and obligations stipulated in this Agreement if this is caused by force majeure.
4. After the force majeure, the PARTIES are obliged to continue all their respective obligations under this Agreement.

Article 9

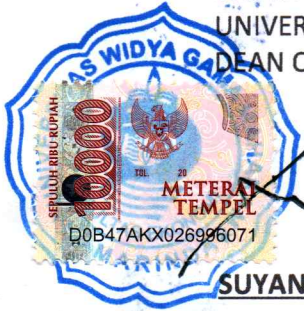
1. If in the future there are developments or changes to matters that have not been regulated in this Agreement, then this Agreement may be added as agreed by the PARTIES;
2. The Additional Agreement (Addendum) as referred to in paragraph (1) above is an inseparable part of this Agreement.

Article 10

Thus, this Agreement is made in 2 (two) copies, each of which has the same text, sufficient stamp duty, has the same legal force and is effective since it was signed by the PARTIES on the day, date, month and year, as stated at the beginning of the Agreement. This Agreement is carried out by the PARTIES with full responsibility.
