



## MEMORANDUM OF UNDERSTANDING

BETWEEN

INSTITUTE OF TARGETED TRAINING FOR PEDAGOGICAL TEACHING PERSONAL NAMED  
AFTER I. Ch. ISAMIDINOV, KYRGYSTAN

AND

UNIVERSITAS WIDYA GAMA MAHAKAM SAMARINDA

This Memorandum of Understanding (MOU), signed on *February 02, 2024*, establishes cooperation between INSTITUTE OF TARGETED TRAINING FOR PEDAGOGICAL TEACHING PERSONAL NAMED AFTER I. Ch. ISAMIDINOV, located in Republic of Kazakhstan, and Universitas Widya Gama Mahakam Samarinda, located in Indonesia.

The MOU outlines the following understandings:

1. **Objective:** Both Participants aim to cooperate in research, education, and training programs of mutual interest.
2. **Areas of Cooperation:** Cooperation will include Journal Management, joint workshops, research projects, joint education programs, staff exchanges, exchange of publications, and other areas of mutual interest.
3. **Exchange Procedure:** Procedures for initiating and supervising cooperative work will involve designated liaison officers, mutual agreement, and signed approvals.
4. **Financial Arrangements:** The MOU does not impose financial obligations, with costs being borne by each Participant. Funding for activities will be determined on a case-by-case basis.
5. **Effect of MOU:** The MOU expresses intentions and does not create legally binding obligations.
6. **Amendments:** Amendments may be requested and agreed upon in writing, becoming part of the MOU.
7. **Entry into Effect, Duration, and Termination:** The MOU is effective upon signing and lasts for five years, extendable by mutual agreement. Either Participant can terminate with three months' notice. Ongoing cooperative work continues until completion.
8. **Protection of Intellectual Property Rights:** Intellectual property rights will be enforced according to national laws and agreements. The use of names and logos is subject to approval. Jointly developed IP is jointly owned, while solely developed IP is owned by the respective Participant.
9. **Confidentiality:** Both Participants agree to maintain confidentiality of shared information, even after MOU termination.
10. **No Agency:** The MOU does not establish a partnership or agency relationship between the Participants.
11. **Notices:** Communications must be in writing in English and delivered personally or via registered mail, email, or fax to the designated addresses.
